Litchfield Transfer Station

Attendant Dana Kilcrease has started a new full-time position at Togus V.A. He is an excellent employee and we will miss his great sense of humor and energy. Dana has been instrumental in bringing this facility into EPA compliance. The Transfer Station welcomes two new employees, who are Litchfield residents, George Noves and John Madore. Both individuals spent an entire day at the Transfer Station during the interview process: both had positive attitudes about the operation. I didn't hold anything back, I advised them about the good, the bad and the ugly about working at the Litchfield Transfer Station: the good: 98% of the people coming to the Transfer Station strongly believe in recycling and appreciate our efforts to operate a professional facility. The bad: the effort it takes to educated our out of state summer population about the changes in our operations. The ugly: the lazy people who cannot be educated about what they need to do at the Transfer Station to make this a successful operation. (I took great deal of time trying to be politically correct about appraisal of these low life lazy individuals). As I mention in my last report: we are excited about starting our 2019 projects (weather permitting, so far it has rained every week, keep your fingers crossed). We need to put in the third cement pad and then move the new forty yard roll off container to that location. In appraising the current recycling situation, I believe the best option, at this time, is to have this third forty-yard container to be used for over flow of cardboard deposits. We will also attempt to run electricity to the Hazmat trailer and the Oil Building. I have outlined our projects but can't emphasize enough that we could not accomplish these goals if it was not for the assistance provided by the Litchfield Public Works Department. _____

Tacoma Lake Association - The dog days of summer are here!! Our recent Annual Meeting, held at The Carrie Ricker School, was a rousing success. Over 75 members enjoyed a great presentation by Toni Pied from the Friends of the Cobbossee Watershed regarding the FOCW's efforts to eradicate milfoil in neighboring lakes. The attending members enjoyed a continental breakfast, and a wonderful feeling of community with fellow members. Our plant patrol team, headed up by Diane Clay continues their work on our lakes scouring the shoreline, looking for invasive plants. They were out this past week on Jimmy Pond, and fortunately found nothing to report. We are always looking for new "patrollers," and our Facebook page has lots of information on upcoming clinics to teach one how to identify the different plants that are in our lakes. Plant patrol information can be found on our website at www.tacomaslakes.org, as well. At the meeting, members were asked if they wanted the option to receive the Spring, and Fall Newsletters electronically, as opposed to the print version. Many indicated they would prefer the electronic version, as a result on the 2020 membership form there will be an option to opt out of the mailing, and space for inputting valid email addresses. Finally, our 2019 membership drive is underway. Last year we had 262 members, and we have set our membership goal for this year at 300. The TLA welcomes anyone who cares about the future health of our lakes to join. ALL of the lakes in this area are considered to be at a high risk for milfoil infestation. This would hurt property values on the waterfront and diminish the local tax base, probably causing more increases for all property owners. We urge all interested people to join, we have kept our membership fees at a very low \$15 per year, and our strength lies in our numbers.

Property Revaluation – The property revaluation process is wrapping up, letters with new property valuations will be sent out by early to mid -August. The tentative schedule is for the staff of RJD Appraisal to be at the Town Office and available for questions and meetings with any tax payer the week of August 12. The selectmen will review results at their August 26th meeting with a target date of September 9th to use the new valuation schedule to commit taxes.

Late-Tax Notices – 30 day notices for unpaid 2018 property taxes will be mailed out the week of the 20th. If taxes have not been paid in full before that mailing, you will incur an additional processing fee to cover the notification.

Augusta, MAINE - To battle the emerald ash borer (EAB) infestation, Maine Forest Service is releasing

attacking immature (larvae) EAB under the bark of ash trees and parasitizing eggs on the surface of the bark. The parasitoid species being released in Aroostook County are Oobius agrili, Tetrastichus planipennisi and Spathius galinae. They were produced and supplied by the USDA APHIS PPO EAB Parasitoids Rearing Facility in Brighton, MI. EAB was found in Aroostook and York Counties in 2018. The northern infestation also includes towns in New Brunswick, where Canadian officials are releasing the same parasitoids. At this time, Department of Agriculture Conservation and Forestry ento-
