LITCHFIELD FOOD BANK

We've learned a LOT of folks in Litchfield don't read the Sodalite to get current, factual information, so feel free to share information about the Food Bank with them. We are here to help Litchfield residents who need it. The application process takes 30 seconds if you write fast, 45 if you don't. You'll need proof of residency like a current utility bill in the applicant's name. Drive through food distribution minimizes contact with staff. Weekly visits can be on Wednesday, 4 - 6 PM or Thursday, 10 AM to noon. Questions, call Rayna 557 -2680. Do you get your groceries "To Go" in paper bags with handles? We'd love them! Single use plastic bags get used again by us! Virus doesn't live beyond 24 hours on them. We'll hold for a week before using, just to be sure.

Senior Center

LITCHFIELD TRANSFER STATION

The "Snow Birds" have started arriving! The Transfer Station had the busiest weekend so far this year.

To date we have issued 1040 new Transfer Station permit stickers. Please advise your "Snow Bird" neighbors to bring a phone bill or other bills to the Transfer Station that show their Litchfield address so we can issue them a Transfer Station permit sticker. Please be advised that May third starts our "Open Sunday" schedule. This will cover the summer to the end of August. JOB NOTICE: we are looking to hire two people to help us with the operation of the Transfer Station during the summer months. Last but not least: MORON ALERT! I hate to beat a dead horse but we are still having people putting items in the wrong containers. People are still putting glass, tin and cardboard in the "Plastic" container. We will start next with a remedial training class. We will provide a training Instrument (coloring book) as well suppling a writing instrument (crayons). Please be advised there will be a test at the conclusion of this training session.

LITCHFIELD BROADBAND COMMITTEE

Broadband internet is a critical utility similar to electricity and clean water that is needed to provide daily services to our homes and businesses. As we are quickly learning in the age of COVID-19, broadband is essential to providing vital links with the outside world and maintaining connections to our loved ones when we need to isolate ourselves in our homes. Our present patchwork of cable TV, phone company DSL, and high-latency satellite services here in Litchfield provide incomplete coverage, with many homes and businesses getting substandard or no service at all. To address this, Litchfield has formed a broadband committee to assess our needs and formulate a plan to implement high-speed internet services to all households and businesses in our town. It is a significant challenge for each small town to do this. We will be actively seeking out neighboring communities to partner with us in the coming weeks. Bundling our needs with those of nearby towns will result in a lower cost on a per town basis. The state agency ConnectME was formed to help support community broadband efforts. It has proposed a State of Maine Broadband Action Plan (available at www.maine.gov/connectme) that calls for the state to invest at least \$30 million per year for five years to meet a goal of having high-speed internet access available to 95% of Mainers by 2025. This would fund 25% of the cost needed to accomplish the goal, with other funds coming from the federal government, municipalities and the private sector. The Legislature is presently considering two measures to begin funding this plan: \$15 million from the general revenue fund surplus and \$15 million in a bond. Please ask your legislators to support this effort. Thank you.

UNITED STATES POSTAL SERVICE

Dear Residents - During these challenging times, postal employees are working hard to ensure residents stay connected with their world through the mail. Whether it's medications, a package, a paycheck, benefits or pension check, a bill or letter from a family member, postal workers understand that every piece of mail is important. While service like this is nothing new to us, we need our communities' help with social distancing. For everyone's safety, our employees are following the social distancing precautions recommended by the Centers for Disease Control and Prevention (CDC) and local health officials. We are asking people to not approach our carriers to accept delivery. Let the carrier leave the mailbox before collecting the mail. With schools not in session, children should also be encouraged to not approach a postal vehicle or carrier. If a delivery requires a signature, carriers will knock on the door rather than touching the bell. They will maintain a safe distance, and instead of asking for a signature on their mobile device, they'll ask for the resident's name. The carrier will leave the mail or package in a safe place for retrieval. We are proud of the role all our employees play in processing, transporting, and delivering mail and packages for the American public. The CDC, World Health Organization, as well as the Surgeon General indicate there is currently no evidence that COVID-19 is being spread through the mail. For vehicles, please include a copy of your valid insurance card, the current mileage and answers to the two questions 1) Is your registration or privilege to register under suspension; 2) Are you required to file a SR-22 form? If you wish to register a recently purchased vehicle please call us.

- **Property taxes may** be mailed-in, or you can use our drop box next to the front door. Please include the address or account number of the parcel for which you are paying taxes.

And for ALL submissions, please include your phone number so we may contact you if necessary. Payments may be made by check, credit card, or cash. Thank you for your cooperation. We will do everything in our power to assist you during this time.

Conservation News

Calling all farm and woodland owners: free invasive plant management plans available. Farm and woodland owners and operators in five Maine counties may be eligible to receive a free invasive plant survey and management plan, prepared by a natural resource professional from the local Soil and Water Conservation District (SWCD). Staff of SWCDs serving Kennebec, Knox, Lincoln, Somerset, and Waldo counties are looking for landowners or operators who would like to learn more about the invasive plants on their farms and woodlands. **Impacts of invasive plants:** Invasive plants like Asiatic bittersweet vines, thorny multiflora rose shrubs, sprawling Japanese barberry, and others can create dense tangles in forests, wetlands, and fields, crowding out native plants and young trees. Along forest edges and hedgerows, thickets of invasive shrubs can reduce the area of productive fields. Some invasive plants create habitat for ticks, cause skin rashes, or are harmful if eaten by livestock. Identify harmful plants and get guidance on management: Many farmers and woodland owners know that invasive plants are present but aren't sure what to do about them. Others may not know how to recognize invasive plants. Having a site visit and survey from the local SWCD is a chance to talk with a natural resource professional, learn to identify harmful plants, and get guidance on how to manage them. Survey data also help scientists understand invasive plant distribution in Maine because data are contributed to the online mapping tool iMapInvasives, the central repository for invasive plant data in Maine. Free, thanks to funders: This service is free to farm and woodland owners or operators thanks to a grant from the United States Department of Agriculture – Natural Resources Conservation Service (USDA NRCS) administered by the Maine Natural Areas Program in the Maine Department of Agriculture, Conservation and Forestry. The project is also funded in part by the Maine Outdoor Heritage Fund, in which proceeds from the sale of a dedicated instant lottery ticket are used to support outdoor recreation and natural resource conservation. Space is limited and landowners/operators must meet basic USDA - NRCS eligibility requirements. Site visits will be conducted during the growing season, but sign-ups are open. Management assistance: Participating landowners and operators are encouraged to act on the management plans they receive by implementing invasive plant treatments. Treatment funding may be available by applying to the USDA NRCS Environmental Quality Incentives Program through the local USDA NRCS office.
